2.11. LIFELINE ASSISTANCE

2.11.1. General

Lifeline Assistance is a federally supported program that provides eligible customers with the following benefits:

- a. A waiver of the Federal Subscriber Line Charge
- b. A reduction of \$14.00 off the customer's monthly basic local exchange service charges.
- Upon the customer's request, free toll limitation services, such as toll blocking, toll control.
- A waiver of the Company's service deposit requirement, if the customer elects to receive toll blocking.

Lifeline Assistance will be implemented in compliance with Federal and/or state guidelines.

2.11.2. Regulations

- Lifeline Assistance is available to residential customers who are currently participating in one of the following assistance programs:
 - Medical Assistance under the New Jersey Code (Medicaid);
 - Food Stamps;
 - Supplemental Security Income (SSI) under Title XVI of the Social Security Act;
 - Federal public housing assistance (Section 8); or
 - Low Income Home Energy Assistance Program (LIHEAP).
