Effective October 1, 2014, the rates for certain ADL services will increase. 9.2. REGULATIONS

9.2.1. Provision of AT&T Digital Link

AT&T Digital Link may be utilized by Customers only for the completion of AT&T local calls that both originate and terminate within the AT&T Digital Link Local Service Area. Calls which terminate or originate outside of the AT&T Digital Link Local Service Area are provided under other appropriate tariffs.

9.3. RATES AND CHARGES

AT&T Digital Link DOD rates include usage-based charges which are billed in arrears, and apply to all AT&T Digital Link DOD calls. DOD usage charges for AT&T Digital Link are determined by the following time periods. AT&T Digital Link DID and MLN rates include non-recurring and monthly recurring charges.

Charges for Direct Inward Dialing Service (DID) (per Channel of the Digital Facility so equipped) or Direct Inward Dialing Service (DID) (per Digital Facility so equipped) do not apply when ISDN-PRI is provisioned on the dedicated digital facilities described in Section 9.1.1, above.*

Direct Inward Dialing and Main Listed Number Service Trunk Establishment Charges are waived for new AT&T Digital Link DID Customer locations.
