Rockland Electric Company ("RECO") hereby submits for filing an original and ten copies of 8th Revised Leaf No. 56 of its Schedule for Electric Service B.P.U. No. 3 – Electricity. This tariff leaf is issued September 30, 2014 to become effective October 1, 2014.

This filing is made in compliance with the Board's actions at its September 30th agenda meeting, which approved the electric Universal Service Fund ("USF") program and Lifeline factors effective October 1, 2014, as shown below.

The above USF and Lifeline factors are included in RECO's Societal Benefits Charge ("SBC"). The changes in USF and Lifeline factors result in a total RECO SBC of 0.6211 cents per kWh, excluding SUT, and 0.6645 cents per kWh, including SUT.

GENERAL INFORMATION

No. 33 SOCIETAL BENEFITS CHARGE ("SBC")

The SBC shall be applied to the kWh usage on the bills of all customers served under this Schedule. The SBC shall include costs, including current costs and any refund or recovery of prior period over- or under-collection balances, related to:

- (1) demand-side management ("DSM"), including the costs associated with DSM programs and DSM bidding programs;
- (2) Clean Energy Program, ("CEP"); and
- (3) Universal Service Fund and Lifeline.

The SBC to be effective on and after the date indicated below shall be set at 0.6645 cents per kWh, including sales and use tax ("SUT"). The SBC includes the following rate components:

The difference between actual costs incurred by the Company for the SBC components described above and SBC recoveries will be deferred, with interest, for future recovery in accordance with the Company's Plan for Resolution of Proceedings approved by the Board in its Summary Order dated July 28, 1999 and Final Order dated July 22, 2002 in Docket Nos. EO97070464, EO97070465 and EO97070466.
