# 5.1 LOCAL ACCESS SERVICE

#### 5.1.1 Description

Local Exchange Access Service provides trunk-side access to the Company's end office switches in the terminating direction only, for use by authorized providers of local exchange telephone service for the completion of local exchange calls that originate and terminate to the Company's End Users in the State of New Jersey. Local Exchange Access Service must be provided to a point of Interface (POI) which will be jointly established by the Company and the Customer at a location within the State of New Jersey and in the same LATA as the Company end office at which the local exchange call will terminate. Local Access Service provides a transmission path between the POI and the Company's End User.

# 5.1.2 Obligations Of The Local Exchange Company (LEC)

- A. The Local Exchange Company may be required by the Company to submit to an annual audit of the authorized local exchange company's billings for Local Access Service. The audit requirement is needed to ensure accurate billing between local exchange calls and non-local exchange calls.
- B. The authorized local exchange company will be required to provide, upon request by the Company, a forecast of total usage for each trunk group or facility ordered from the Company for each POI used in a Local Access Service arrangement.

Its fiber optic ring architecture transports data at an aggregate channel speed of 100 Mbps and features automatic protection switching to eliminate service outages in the event of a station or facility failure. FDDI Service is available in either two-point or multi-point channel configurations.
