Cypress Communications Operating Company, LLC ("Cypress") hereby files this TSP Departure Application ("Application") with the New Jersey Board of Public Utilities ("Board").

I. THE PETITIONER

Cypress is a Delaware limited liability company with its primary place of business located at 75 Erieview Plaza, Suite 400, Cleveland, Ohio 44114. On December 19, 2002, Cypress was authorized to provide local exchange and IXC services in New Jersey under Docket No. TE00060418. Cypress specializes in Voice over Internet Protocol services ("VoIP"), which allow customers to make and receive voice communications over the Internet. Cypress primarily sells VoIP-based shared tenant services to business customers. Cypress has no residential customers.

Correspondence regarding this Petition should be directed to counsel for Petitioner, as set forth below.

II. DESCRIPTION OF THE TRANSACTION

Cypress hereby seeks Board approval to cease operations in New Jersey. Changing market conditions require Cypress to wind down its operations in New Jersey, as well as nationally. Subject to Board approval, Cypress will cease all operations on May 2, 2015 (the "Departure Date"). Cypress also hereby requests cancellation of any active tariffs that it may have in New Jersey.

As required under New Jersey law, Cypress will unlock all E-911 records. Cypress currently has no NXX codes assigned. Cypress is sending a notification letter to all affected customers. Cypress provided advance notice to the affected customers approximately (60) days prior to the Departure Date, explaining that customers must find a new service provider. The letter is attached as Exhibit A for the Board's reference. Cypress expects that the customers will have transitioned to a new carrier before the Departure Date.

Cypress has only seven customers in New Jersey and for competitive reasons hereby requests waiver of the requirement to supply end user lists per N.J.A.C. 14:10-12.7. Alternatively, Cypress is willing to file the names under seal upon Commission request. Although there is no acquiring TSP, Kyle Bertrand (216-373-4636) will serve as migration manager to assist customers in transitioning to a new provider of their choice.

III. PUBLIC INTEREST STATEMENT

Cypress's departure from New Jersey will not harm the public interest. First, Cypress has almost no presence in New Jersey. As of the date of this Application, Cypress has only seven customers within the state, all of which are business customers and six of which occupy a single office building. Note that Cypress has no residential customers. Second, Cypress will assist customers in locating a new service provider. For customers that may have difficulty in finding a

new provider, Cypress is notifying customers that Fusion Telecommunications International, Inc. may be a suitable option. The notices clearly state, however, that customers are free to select a provider of their choice.

Finally, Cypress will work diligently to assist customers in making a seamless transition to a new service provider, regardless of which providers are selected. Cypress will assist customers with porting their telephone numbers as needed and will unlock all E-911 records. Cypress is providing a toll-free number for customers to call if they have questions. This number will remain active for at least 60 days after the Departure Date.

IV. <u>CONCLUSION</u>

For the reasons stated herein, Cypress respectfully requests the Board grant this Application, approving the departure of Cypress from the State of New Jersey.
