

IN THE MATTER OF THE PETITION OF COMCAST OF GARDEN STATE L.P., FOR A RENEWAL CERTIFICATE OF APPROVAL TO CONTINUE TO CONSTRUCT, OPERATE AND MAINTAIN A CABLE TELEVISION SYSTEM IN AND FOR THE BOROUGH OF AUDUBON PARK, COUNTY OF CAMDEN, STATE OF NEW JERSEY

#### VERIFIED PETITION

Docket No.

Comcast of Garden State L.P. (hereinafter "Comcast" or "Petitioner"), hereby petitions the Honorable Board of Public Utilities (the "Board"), pursuant to 47 <u>U.S.C.</u> §546(c), <u>N.J.S.A.</u> 48:5A-15, -16 and -17, <u>N.J.A.C.</u> 14:17-6.9 and <u>N.J.A.C.</u> 14:18-13.1 *et seq.*, for renewal of a Certificate of Approval. In support of its Petition, Petitioner states as follows:

### **COUNT ONE**

- 1. Comcast, a limited liability company duly organized under the laws of the State of Delaware, is a cable television company subject to the jurisdiction of the Office of Cable Television ("OCTV") and the Board, pursuant to N.J.S.A. 48:5A-1 et seq.
- Comcast maintains its principal offices at 1250 Audubon Park-Berlin Road, Cherry Hill, New Jersey 08034.

- 3. On or about March 21, 1975, in Docket No. 749C-6053, pursuant to N.J.S.A. 48:5A-17(a) and (b) and N.J.S.A. 48:5A-28(c), the Board issued a Certificate of Approval to Cable Systems, Inc. ("Cable Systems") to provide cable television service in the Borough of Audubon Park ("Borough" or "Audubon Park"). A copy of said Certificate is on file with the OCTV.
- 4. On November 6, 1980, in Docket No. 8010C-6722, the Board approved the transfer of the Certificate of Approval with respect to Audubon Park from Cable Systems to New York Times Cable Company of New Jersey ("NYT").
- 5. On July 26, 1989, in Docket No. CM89030342, the Board approved the transfer of the Certificate of Approval with respect to Audubon Park from NYT to Garden State Cablevision, L.P. ("Garden State").
- 6. On September 26, 1991, in Docket No. CE91061036, the Board issued to Garden State a Renewal Certificate of Approval to continue to provide cable television service in Audubon Park. A copy of said Certificate is on file with the OCTV.
- 7. On or about January 5, 2000, in Docket No. CM99110855 the Board authorized the merger Lenfest Communications, Inc., which owned a 50% interest in Garden State, with and into a wholly-owned indirect subsidiary of Comcast Corporation, which owned the remaining 50% interest. As a result of said merger, Garden State, later renamed Comcast of Garden State L.P., Petitioner herein, became indirectly wholly-owned by Comcast Corporation.
- 8. On August 17, 2000, in Docket No. CE99100817, the Board issued to Petitioner a Renewal Certificate of Approval to continue to provide cable television service in Audubon Park. A copy of said Certificate is on file with the OCTV.
- 9. Pursuant to N.J.S.A. 48:5A-1 et seq. and N.J.A.C. 14:18-13.3(a)3, on or about June 20, 2014, Petitioner submitted an Application for Renewal of Municipal Consent

(hereinafter the "Municipal Application") to continue to construct, operate and maintain the System in Audubon Park.

- 10. On or about December 1, 2014, a public hearing was held by Audubon Park with respect to Petitioner's Municipal Application, during which all interested persons desiring to be heard were so heard.
- 11. On or about May 4, 2015, Audubon Park adopted Ordinance #2015-02 (the "Ordinance") granting to Petitioner renewal of its Municipal Consent ("Renewal of Municipal Consent") to continue to construct, operate and maintain the System in Audubon Park. A copy of the Ordinance is annexed hereto as Exhibit A.
- 12. On or about May 12, 2015, Comcast filed its formal acceptance of the terms and conditions of the Renewal of Municipal Consent granted by Audubon Park, pursuant to N.J.S.A. 48:5A-24. A copy of said letter of acceptance is annexed hereto as Exhibit B.
- Television, together with the information contained in its Application for Renewal of a Certificate of Approval ("COA Application"), which is simultaneously submitted herewith, all of which information is adopted by reference thereto, establishes the requisite criteria for the continued construction, ownership, operation and management of the System in the Borough by Comcast.
- operation of the System. Further, as indicated in the COA Application and other information on file with the OCTV, Comcast possesses the necessary financial integrity and the ability to perform efficiently the proposed services and those services which may be required by the public convenience and necessity during the renewal period. The public convenience and necessity generally support the appropriateness of the issuance of a Renewal Certificate of Approval to Petitioner.

15. Petitioner has complied, and will continue to comply, with all rules, regulations and laws applicable to the construction, operation and maintenance of the System and will continue to provide safe, adequate and proper cable television service in the Borough of Audubon Park and the other municipalities in which it serves.

#### COUNT TWO

- 16. Comcast repeats paragraphs 1 through 15 of COUNT ONE as if set forth fully hereinafter.
- 17. As set forth in the Municipal Application, the COA Application and other information on file at the OCTV, the System operated by Comcast in the Borough is part of larger regional Comcast and Comcast-affiliated cable television systems serving numerous other municipalities contiguous to and surrounding the Borough.
- 18. As also set forth in the Municipal Application, the COA Application and other information on file at the OCTV, the Borough represents an integral part of the Comcast and Comcast-affiliated regional cable television systems serving the counties of Atlantic, Burlington, Camden, Gloucester and Salem. In addition, the demographics of the Borough, as well as its location and other factors, mandate that cable television service be provided by Comcast as part of Comcast's and its affiliates' regional systems.
- 19. The Audubon Park portion of Comcast's and its affiliates' Atlantic, Burlington, Camden, Gloucester and Salem County regional cable systems is necessary for the continued provision of safe, adequate and economical cable television service to the citizens and residents of the Borough and the larger cable television systems generally. Further, continuation of Comcast's operating authority in the Borough will avoid an unreasonable duplication of services which would otherwise be detrimental to the development of adequate cable television service.

- 20. Comcast is entitled to a renewal of its Municipal Consent and Certificate of Approval, pursuant to the provisions of Section 17(b) of the New Jersey Cable Television Act, N.J.S.A. 48:5A-1 et seq.
- 21. Comcast believes that a Renewal Certificate of Approval for the Borough of Audubon Park is necessary and proper for the public convenience and will serve the public interest for reasons which include, *inter alia*, the following:
- (a) The grant of a Renewal Certificate of Approval to Comcast will ensure the continued provision of safe, adequate and proper cable television service to the residents of the Borough;
- (b) The services provided and to be provided by Comcast as set forth in its Municipal Application and its COA Application are and will be of great benefit to the citizens and residents of the Borough;
- (c) The financial strength and technical expertise of Comcast are more than adequate to continue to construct, operate and maintain its cable television system in the Borough of Audubon Park; and
- (d) Comcast, its officers and directors, have vast experience in all aspects of cable television. In particular, they possess and represent the highest degree of technical and engineering competence, significant administrative experience and a demonstrated responsiveness to community needs. In addition to Audubon Park, Comcast and its affiliates hold Certificates of Approval or other authorization to construct, operate and maintain cable television systems in more than 340 municipalities in New Jersey, as well as additional communities in 38 other states.

WHEREFORE, it is requested that this Honorable Board of Public Utilities issue to Comcast of Garden State L.P., a Renewal Certificate of Approval to continue to construct, operate and maintain a cable television system in the Borough of Audubon Park.
