2. I offer this Affidavit in support of the Company's claim that its Schedules to the Company's 2018 – 2019 BGSS/CIP Filing listed below are and should be maintained as confidential in this proceeding:

TWR-5 (Guidelines)
TWR-10 (Affiliate Transactions)
3. SJG, the Staff of the Board of Public Utilities and the Division of Rate Counsel (collectively, the "Parties") entered into an Agreement of Non-Disclosure of Information Claimed to be Confidential (the "NDA").
4. Pursuant to the NDA, the Parties agreed not to disclose the contents of any "Confidential Information", including information the providing party may claim constitutes or contains market-sensitive, competitive, confidential, trade secret or proprietary information.

5. The information contained in the Schedules includes, *inter alia*, confidential and proprietary data.


6. Moreover, the information contained in the Schedules is not routinely available to the public in any manner.

7. If other vendors to South Jersey became aware of the information contained in the Schedules, this would result in harm to South Jersey and its customers.

8. Revealing the terms and conditions of the Schedules to the public would unfairly place South Jersey at a competitive disadvantage among its vendors.


9. The Company will make the Schedules available to the Parties to this proceeding who have executed the NDA.
