BACKGROUND:

On March 5, 2020, pursuant to N.J.S.A. 48:5A-19 and N.J.A.C. 14:7-6.8, CSC TKR, LLC ("CSC TKR"), a wholly-owned subsidiary of Altice USA, Inc. (together, "Altice"), and Service Electric Cable T.V. of New Jersey, Inc. ("Service Electric") (collectively, "Petitioners"), jointly filed a verified petition ("Petition") requesting that the New Jersey Board of Public Utilities ("Board") approve the transfer of 28 certificates of approval and related authorizations and the accompanying cable systems, including all assets set forth in Asset Purchase Agreement from Service Electric to Altice.

Shortly after an initial review of the filing, Staff informed the Petitioner that the filing was incomplete and during calls on March 13 and 19, 2020, advised them that they must supplement the Petition. The filing was devoid of documents including but not limited to requisite proofs and unredacted information; and failed to seek Board approval of the acquisition of control of Service Electric by Altice through the purchase of assets, pursuant to N.J.S.A. 48:5A-38 and 40 and N.J.A.C 14:17-6.10. On March 18, 2020, Petitioner's counsel filed a letter addendum to the Petition referencing N.J.S.A. 48:5A-38 and 40 and including some of the omitted information. Concurrently, the Petitioner filed the requested disclosure schedules with the Board Secretary that were not provided with the initial filing and were redacted in the previous submission.

In addition, upon review of the Company's submissions, the Notice of the transfer published in the service area reflects that inspection of the petition can be conducted at the company's offices. Since the current circumstances do not permit such inspection, by this Order we seek notice to subscribers by way of bill insert or by republication in at least one newspaper circulated in the Company's service area. Such notice shall provide instructions to the public of their ability to review the petition electronically on the Company's website and to file comments on the petition with the Board at board.secretary@bpu.nj.gov under Docket No. CM20030211 no later than July 1, 2020.

On March 27, 2020 the Board issued an Order designating Commissioner Chivukula as Presiding Officer. Within the Order, the deadline of April 14, 2020 was set for motions to intervene and pro hac vice. No motions to intervene were received.

On April 2, 2020 the Petitioner amended their March 5th filing pursuant to Board Staff's request for information essential for the filing to be complete. Accordingly, the record has been updated.

Pursuant to federal statute and FCC regulations which set forth the prescribed 120-day period for review, the timeline commences upon the filing of a "completed FCC Form 394, together with all exhibits, and any additional information required by the terms of the franchise agreement or applicable state or local law." See 47 U.S.C. § 537; 47 C.F.R. § 76.502(b). Responses to information requests by Board Staff were submitted by the Petitioner. The completed application and accompanying documents collectively were received on or about April 2, 2020. Therefore, the statutory 120-day period for review expires on July 31, 2020.

PREHEARING ORDER

1. NATURE OF PROCEEDINGS AND ISSUES TO BE RESOLVED

Through this proceeding Altice and Service Electric Cable T.V. of New Jersey Inc. seek Board approval of the transfer to Altice of the cable television system assets, accompanying licenses and franchises owned and operated by Service Electric through a purchase of Service Electric's assets and acquisition of the cable television system, pursuant to N.J.S.A. 48:5A-19, 38 and 40 and N.J.A.C. 14:17-6.8 and 6.10.
