ROBERT SOKOTA, being of full age, certifies as follows:

1. I, ROBERT SOKOTA, make this Certification pursuant to N.J.A.C. 14:1-12.8. I am the General Counsel and Chief Administrative Officer of Petitioner ZenFi Networks, LLC (“ZenFi” or “Petitioner”). I have knowledge of the facts set forth herein regarding the information for which confidential protection is sought from the Board of Public Utilities (“Board”).

2. Petitioner ZenFi and its corporate members are privately owned and are not required to file the information marked as Confidential in the Petition Verified Petition (collectively the “Confidential Information”) publicly or with any governmental body. All such information is treated and maintained as proprietary and confidential by the Petitioner and its corporate members and not disclosed to third parties except pursuant to obligations to maintain the confidentiality of such information.

3. Public disclosure of the Confidential Information would be harmful to Petitioner and its corporate members because such disclosure would allow competitors to view sensitive

competitive information regarding Petitioner's access to financial credit and would reveal to competitors of Petitioner's corporate members financial information regarding that entity that is not otherwise available from any source outside its control. Petitioner and its corporate members do not have access to similar confidential information regarding their competitors.

4. To date, Petitioner has consistently protected the confidentiality of its Confidential Information by all possible means, including placing appropriate markings on documents and restricting access to such information to designated employees and agents. Petitioner has not disclosed the Confidential Information at the level of detail contained in the Verified Petition to the public, and it certainly has not disclosed this information to its competitors.

5. Accordingly, Petitioner requests that the Board maintain in confidence all information marked as Confidential that is provided in connection with this Verified Petition and that the Board not disclose such Confidential Information to any third party without the prior consent of Petitioner and the application of confidentiality requirements upon any receiving party.
