Discontinuance of Some Voice and Data Services

Dear Ms. Asbury:

Broadwing Communications, LLC ("BRW") is discontinuing some voice and data services. The Company filed an application on January 24, 2020 with the Federal Communications Commission (FCC) and notified affected business and wholesale customers of the discontinued services by letter via U.S. mail on January 22, 2020. Broadwing Communications, LLC has no residential customers. Since January, Broadwing has continued to work with the impacted business customers to transition to other providers or to services offered by Broadwing affiliates.

Enclosed for filing please find revisions to Broadwing Communications, LLC Wholesale Interexchange Telecommunications Service N.J. B.P.U. Tariff No. 1, Broadwing Communications, LLC Retail Telecommunications New Jersey BPU Tariff No. 2, and Broadwing Communications, LLC Local Tariff B.P.U. N.J. No. 3.

For Broadwing Communications, LLC Wholesale Interexchange Telecommunications Service N.J. B.P.U. Tariff No. 1 the filing removes resold switched and dedicated long distance, toll free, calling card services, and dedicated access lines from Section 3, Section 4 – Reserved for Future Use, and directory assistance, operator assistance, prepaid calling, and casual calling from Section 6.

The Company will withdraw Broadwing Communications, LLC Retail Telecommunications New Jersey BPU Tariff No. 2 and no longer provide long distance operator services (dial "00").

For Broadwing Communications, LLC Local Tariff B.P.U. N.J. No. 3, the filing removes Basic Line Service, Basic Trunk Service, DID Trunk Service, Digital Trunk Service, ISDN PRI, Inbound Digital DID Service, Virtual Exchange Service, Integrated Voice and Data (IVAD) Service, Direct Inward Dial (DID) Service, Local Number Portability (LNP), Digital Data Service (DDS), Remote Call Forwarding (RCF), Resold Local Exchange Service, and the associated miscellaneous services that include but are not limited to Custom Calling Features, Operator Services, Directory Assistance, Local Calling Service, and IntraLATA Calling Service. Broadwing Communications, LLC will continue to provide Private Line and Access services.



The Company filed an application on January 24, 2020 with the Federal Communications Commission (FCC) and notified affected business customers of the discontinued service by letter via U.S. mail on January 22, 2020. CenturyLink has provided notification more than 30 days before the requested effective date for a withdrawal of service. A copy of the January 22, 2020 customer notice is attached.
