2. I am a 1997 graduate of Harvard University and I graduated from Harvard Law School in 2006.
3. I am a Partner at the firm of Jenner & Block LLP, having offices at 1099 New York Ave., NW, Washington DC, 20001.
4. I was admitted as a member of the Bar of the District of Columbia in 2010, and am an attorney in good standing admitted to practice law in the District of Columbia.
