On behalf of Jersey Central Power & Light Company ("JCP&L" or "Company"), enclosed for filing in the above-referenced matter is a Petition requesting approval of the sale of property located at 218 39<sup>th</sup> Street-East, Block 39.04, Lots 31 and 32, Unit CA ("Parcel CA") and 218 39<sup>th</sup> Street-West Block 39.04, Lots 31 and 32, Unit CB ("Parcel CB") in Sea Isle City, Cape May County, New Jersey (collectively referred to as the "Parcels") to Noodles 1, LLC ("Buyer") for a purchase price of \$1,050,000.

As explained in the Petition, the sale of the Parcels to the unaffiliated Buyer will not adversely affect the public interest, and will not compromise the ability of the Company to render safe, adequate and proper service to its customers. The Parcels, which were acquired in connection with the Company's manufactured gas plant ("MGP") remediation efforts, in this case at the site of the former Sea Isle City MGP, the costs and details of which are reviewed in proceedings before the New Jersey Board of Public Utilities (the "Board") under the Company's Remediation Adjustment Clause ("Rider RAC" or the "RAC"), have been remediated and are not used or useful for utility purposes.

The sales price represents the fair market value of the Parcels based on the results of the advertising and marketing process described in the Petition. The Company's Petition further addresses all the required elements and factors as set forth in N.J.A.C. 14:1-5.6. Therefore, the
