The Office of Cable Television and Telecommunications ("OCTV&T") is in receipt of the above captioned Petition for Renewal Certificate of Approval and attached application for the Borough of Bernardsville ("Borough"). The OCTV&T staff have completed a review of the file would like the company to provide the following information in this matter:

- Section I. Organization and Management, Subsection 1. System Personnel (if not applicable so indicate) Subsection G:** This section requires the applicant to provide information for the Personnel indicated for operations positions shall be those person who, in fact will have responsibility, authority and control of the day-to-day system construction and operation. Staff notes that the application has listed Charles Smith as the Director of Government & Regulatory Affairs and his phone number. However, Mr. Smith is no longer with the Company. Please provide updated information for this section, including Director of Government & Regulatory Affairs, with the associated contact information.
- Section IV. System Design Subsection 4:** This section of the application requires the company to list the type of channels, proposed inception, and cable channel designation that has been agreed upon between the municipality and company. Staff notes that part of the application question has been removed. Below is the complete question in the application, which can be found on the BPU Website. Please revise the application page appropriately.
4. Each applicant shall title by category and list the following information concerning program origination;

3. **Section VI. System Plant Subsection 4:** This section of the application requires a Map of the entire Municipality be attached as an appendix. Please note that the current map submitted with the application, does not meet the criteria that is listed in the application. Staff notes that the current map is missing a Map Legend, Municipality Borders, all streets which are to receive services which should indicate the Primary Service Area, and all streets which will be served under a "Line Extension Policy" ("LEP").

Please submit a map that is legible and meets all of the following criteria; The Proposed Map is currently missing the following:

1. Map Legend
 2. Municipal Borders
 3. All of the streets should be labeled, legible and note which are to receive service as the Primary Service Area and the Area Designated for LEP
4. **Section XVI. Verification:** This section of the application requires the Sr. Director of Government and Regulatory Affairs for Comcast of Central New Jersey II, LLC to verify that they are authorized on part of the applicant to file with the Borough the application and appendices attached thereto. Staff notes that Charles Smith was listed as the Sr. Director of Government & Regulatory Affairs. However, Mr. Smith is no longer with the company and no signature was provided for this section. Please provide a revised application page that includes the signature and contact information for the Senior Director of Government and Regulatory Affairs.
5. **Application Appendix G:** Staff notes that Appendix G Annual Notice referenced in the Application was not attached to the application as an appendix. Please provide an application page that addresses the missing Appendix G Annual Notice.
