The Office of Cable Television and Telecommunications ("OCTV&T") is in receipt of the above captioned Petition for Renewal Certificate of Approval and attached application for the Township of Raritan ("Township"). The following is a request for additional information the OCTV&T would like the company to furnish prior to the completion of our review:

- 1. <u>Section I. Organization and Management Subsection 13:</u> This section of the application requires the company to list the address and telephone number of the designated local office or agent located within the system, available to receive, investigate and resolve any complaints the subscriber may encounter. Staff notes that the office listed in the application for the NJBPU Office of Cable Television, 44 S. Raritan Ave. 3rd fl., Trenton, New Jersey, is not the correct address for the OCTV&T. Please provide a revised application page that clarifies the appropriate OCTV&T office address.
- 2. <u>Section II. Legal and Character Qualifications Subsection 6</u>: This section of the application requires, in part, information if the applicant, or any principal, directly or indirectly own, operate, control or have more than three percent interest. For each affirmative response, attach a statement containing specifics including percentage of ownership. The response provided was, **See Appendix**. However, the attachment to the application for Appendix B., Ownership Percentages was not provided. Please provide the OCTV&T with a copy of the attachment for Appendix B. of the application.
- 3. <u>Index to Appendices:</u> Staff notes that the Community Access Appendix attached to the application states that it is for Comcast of Central New Jersey, LLC, which is the wrong system. Please provide the OCTV&T with a Community Access Appendix for Comcast of Central New Jersey II, LLC.

Additionally, attached to the application is an Appendix G. Annual Notice that is not listed in the Index to Appendices section of the application. Please revise the application page to include the Appendix for the Annual Notice.
