The Office of Cable Television and Telecommunications ("OCTV&T") is in receipt of the above captioned Petition for Renewal Certificate of Approval and attached application for the Township of Frelinghuysen ("Township"). Staff notes there is a problem with the Company's acceptance of the ordinance, as provided with the Petition.
