The Office of Cable Television and Telecommunications ("OCTV&T") is in receipt of the above captioned Petition for Renewal Certificate of Approval and attached application for the Township of Frelinghuysen ("Township"). The following is a request for additional information the OCTV&T would like the company to furnish prior to the completion of our review.

Staff notes there is a problem with the Company's acceptance of the ordinance, as provided with the Petition. The Township adopted the ordinance on November 18, 2020, and subsequently amended a section of the ordinance on January 20, 2021 to provide clarification regarding free services. On December 28, 2021, the company accepted the ordinance adopted on November 18, 2020, however, it did not include the amendment to the ordinance. The ordinance must be accepted in its entirety, including the amendment to the ordinance. Please provide the OCTV&T and the Township with a letter indicating that the company accepts both the Ordinance adopted on November 18, 2020 and the amended ordinance adopted on January 20, 2021.
