- 1. Cablevision is a cable company as defined under the provisions of the New Jersey Cable Television Act., N.J.S.A. 48:5A-3(g), and is the current holder of a Certificate of Approval issued by this Honorable Board, for the construction, operation and maintenance of a cable system in the Township of Hope (hereinafter "Municipality"), County of Sussex, State of New Jersey. 4. By letter dated May 25, 2022, Cablevision accepted the terms of the Municipality's

Ordinance. A copy of said correspondence is attached hereto as **Exhibit C**.

5. CSC TKR, LLC maintains a local office for the use of its customers at 320 Sparta

Avenue, Sparta, New Jersey 07871.

6. Cablevision has been operating its cable system within the Municipality in

compliance with applicable federal and state law and in conformance with the rules, regulations

and orders of the Board. Cablevision has fulfilled its material commitments set forth in the

existing Certificate of Approval.

7. The granting of the within Petition for renewal of Cablevision's Certificate of

Approval is necessary and proper for the public convenience and will serve the public interest as

Cablevision has the financial, legal and technical ability to provide the proposed cable services

during the term of the renewal.
