PLEASE TAKE NOTICE that Gordon's Corner Water Company ("Company"), a public utility of the State of New Jersey, filed a Petition with the Board of Public Utilities ("Board") on October xx, 2023 to increase rates for water service through an adjustment in the level of its Purchased Water Adjustment Clause ("PWAC") pursuant to N.J.A.C. 14:9-7.1 et seq., and N.J.S.A. 48:2-21.

The proposed PWAC adjustment would increase annual revenues by \$1,201,629 or 8.6% over present revenues. The proposed rate adjustment provides no profits to the Company and represents a pass-through of charges to the Company from its water suppliers.

The following comparison of present and proposed rates permits customers to determine the effect upon them of the proposed increase in rates:
